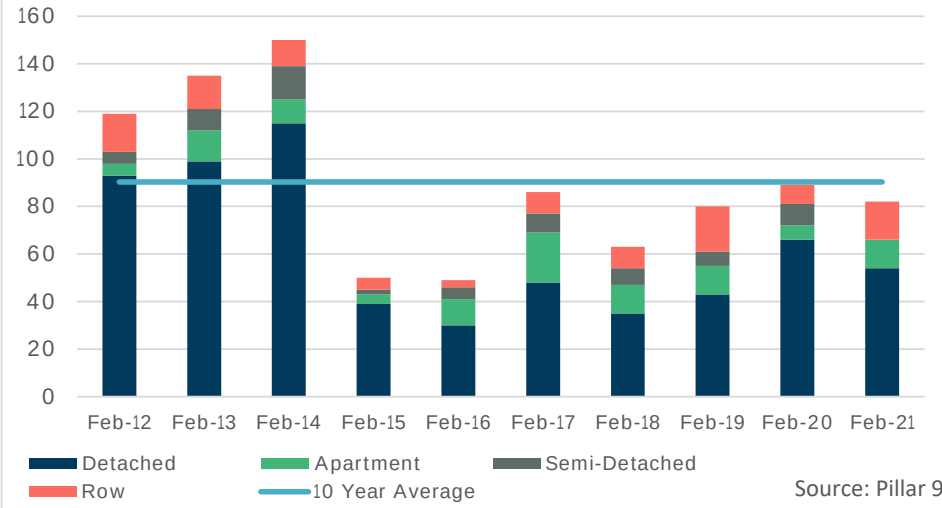

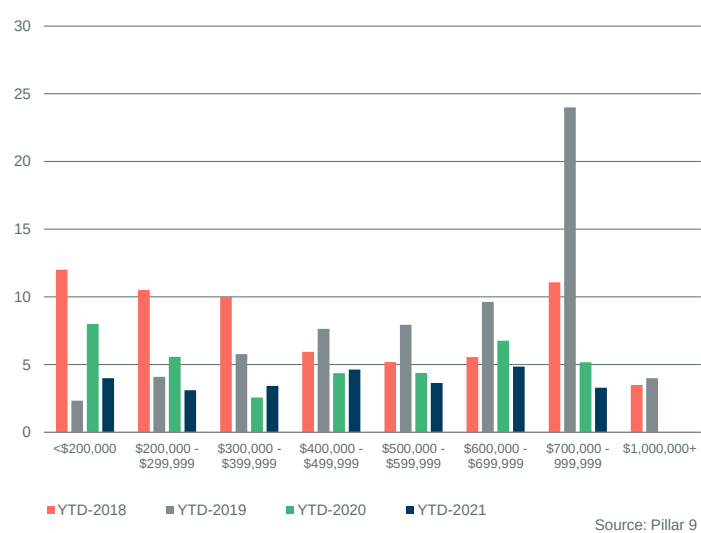


MONTHS OF SUPPLY BY PRICE RANGE



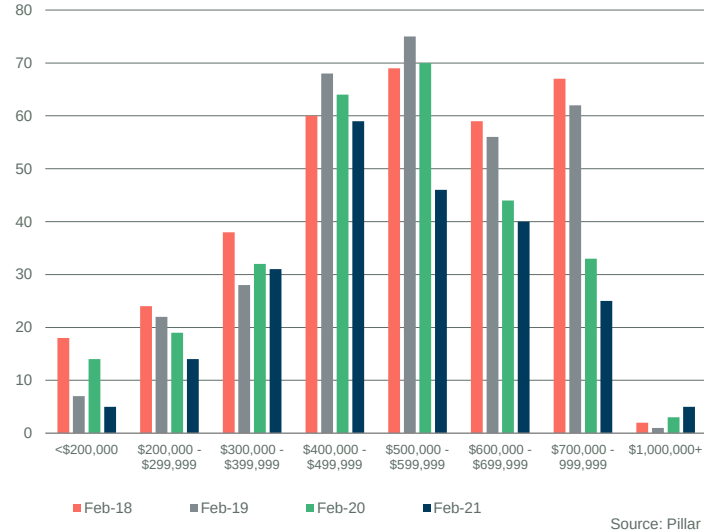

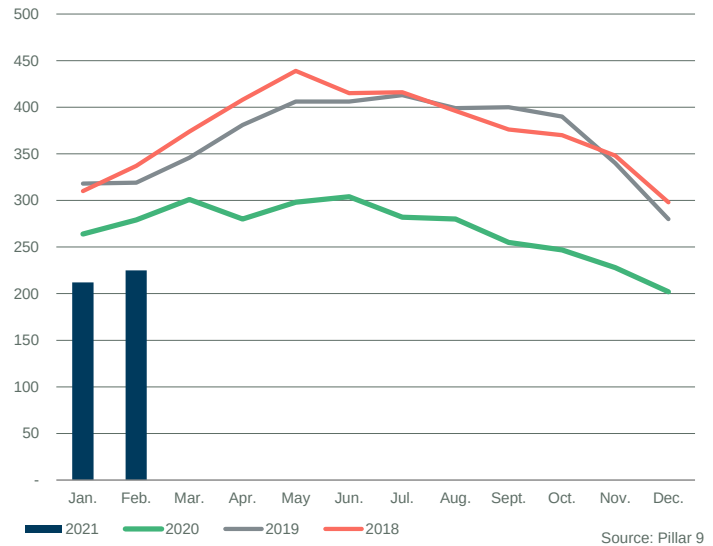

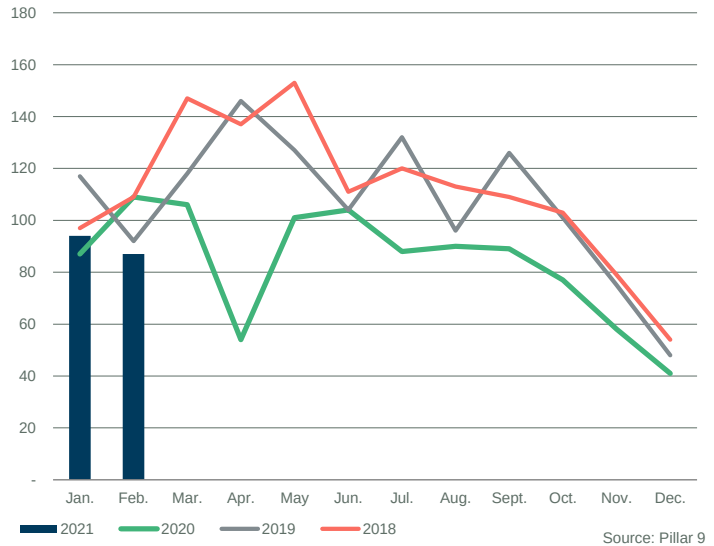

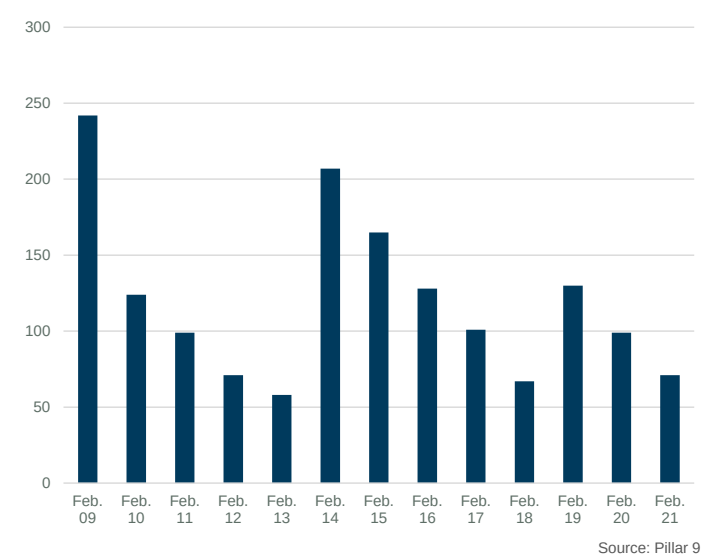
MONTHS OF SUPPLY AND PRICE CHANGE



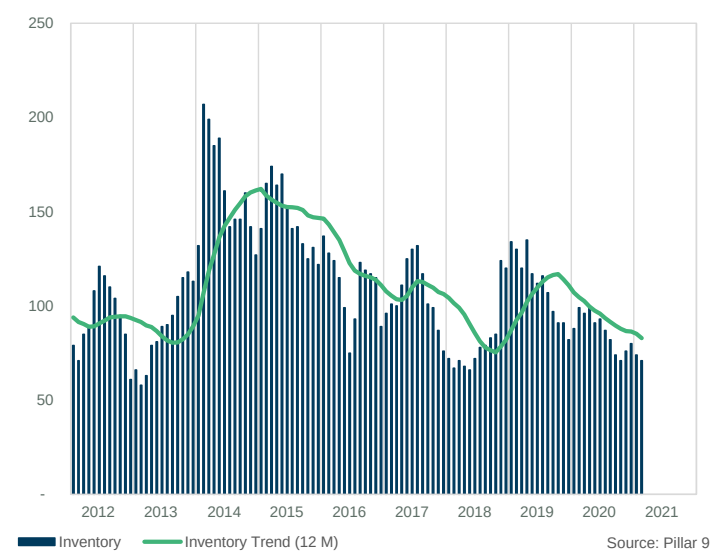

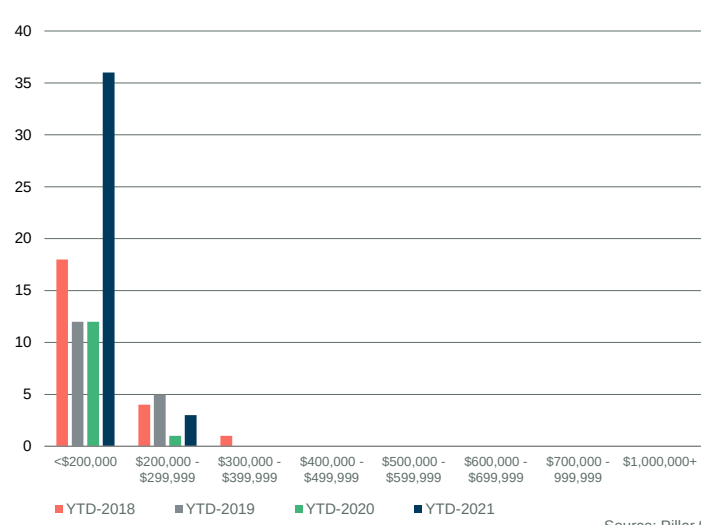

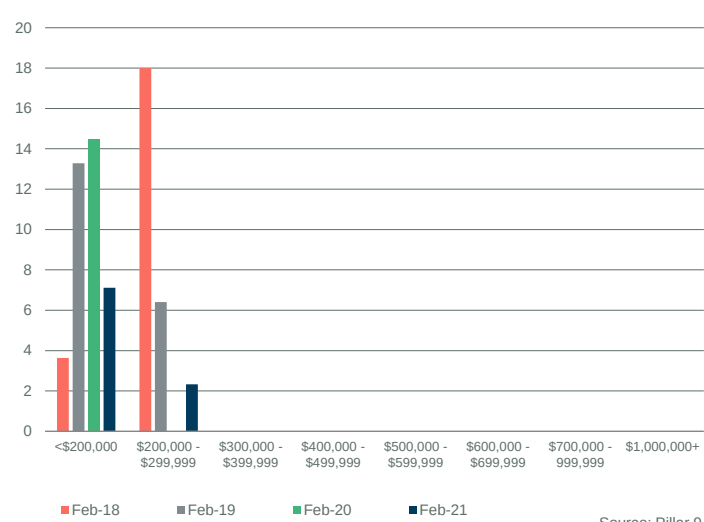
YTD SALES BY PRICE RANGE

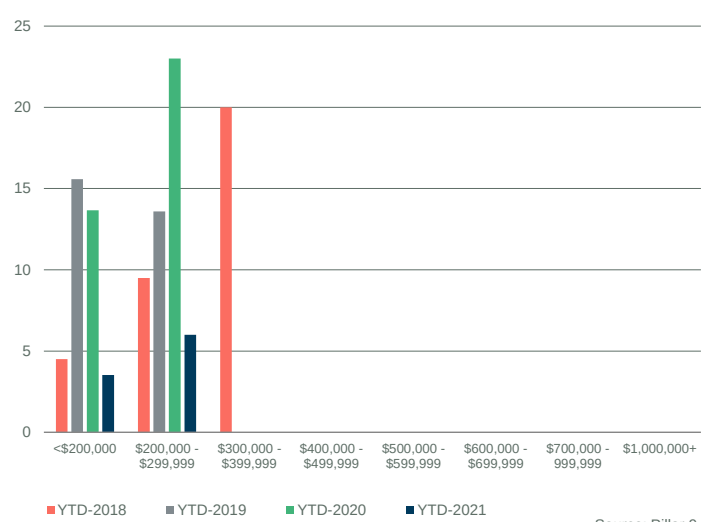
MONTHS OF SUPPLY BY PRICE RANGE

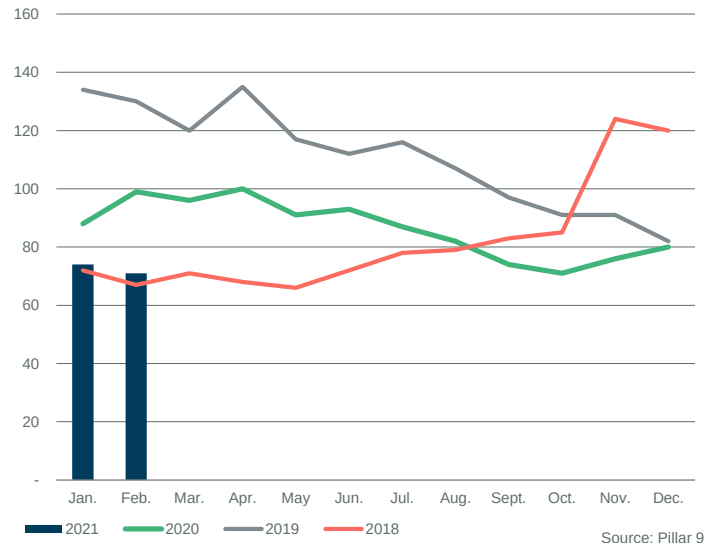

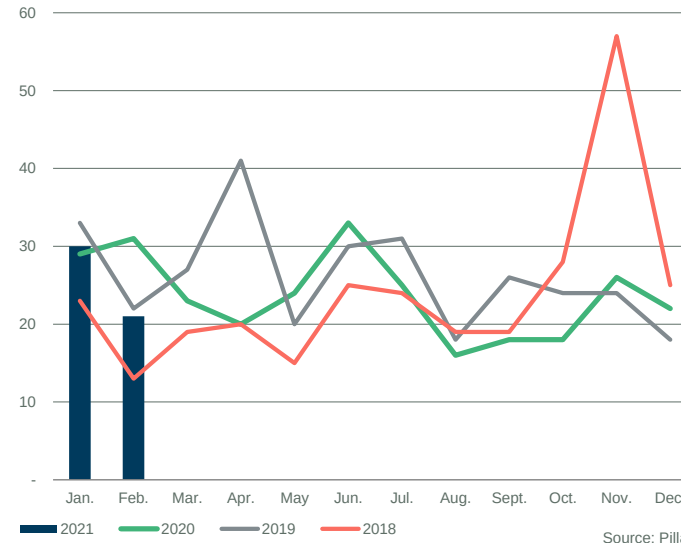
